Call to Artists

The Call

Applications for the 21st annual ArtSplash Art Show and Sale are now available. The Tualatin Arts Advisory Committee, a public arts citizen committee of the City of Tualatin Oregon, invites artists to submit an application for this annual juried summer art sale. The goal of the Tualatin Arts Advisory Committee is to encourage and promote Northwest artists, expose the community to a wide range of artistic experience, and endorse interaction between artists and the community. Proceeds from ArtSplash go to support the public arts in Tualatin.

Important Dates:

- May 3, 2016 Application deadline
- May 27, 2016 Notification of acceptance or rejection
- June 10, 2016 Participation fees due
- July 1, 2016 Last day to cancel

Show Dates and Hours

Fees

\$35 non-refundable application fee (Fee is per artist. Artists may submit separate applications for more than one medium and still pay just one application fee.)

Booth Space Options

Space inside main tent:

Single Space – ArtSplash provides two 37 ½" x 72" panels OR one 8'x30" table
\$100 Tualatin Resident or \$125 Non-resident

Double Space - ArtSplash provides four 37 ½" x 72" panels OR two 8'x30" tables

Double spaces are limited. Once the jury process is complete, artists will be given the option to request a double space. The double spaces are assigned on a first come, first served basis.

\$190 Tualatin Resident or \$240 Non-resident

New this year!

10x10 Booth Space on the Plaza- This year a limited number of 10x10 canopy spaces will be available on the plaza next to the main tent. Artists will be responsible for providing their own canopy and display materials.

Site

ArtSplash is located at the beautiful Lake of the Commons in Tualatin, 8325 SW Nyberg Street. The Tualatin Commons is the vibrant heart of downtown featuring a wide pedestrian promenade surrounding a three acre lake. Public plazas and a fountain add to the lively urban mix. Tiles and artist designed drinking fountains are integrated into the plazas. ArtSplash is a three day outdoor show featuring approximately 50 northwest artists overlooking the Lake of the Commons.



Displays Options

There are three display options depending on the artists' medium and preferences:

1. A wire rack display which consists of **two 37-1/2" x 72" panels** will be provided for the artist. Artists may also bring one small table, a folding art rack for prints and a chair. The racks will set up and ready to hang art. Upon check in artists will be provided with 25 hooks for hanging artwork. Unframed works can be displayed in bins.
2. **One 8'x30" table.** Tables provided to artists will be covered with a plastic cover and ready for artist display. Artists may also bring a chair.



3. **10x10 Booth Space** on the plaza. Artists will provide their own canopy, tables, racks, and other display items. Canopies with optional walls that can be closed at night are recommended.

Electricity

ArtSplash is an outdoor show and power is very limited at the Tualatin Commons. Electricity is not available to all artists. Power needs will be reviewed on a case by case basis.

Commission/sales tax

No commission is taken on sales. There is no sales tax in Oregon

Security

There will be security on duty during the hours that the show is closed. This includes Friday evening, Saturday morning and evening, and Sunday morning.

Central wrap

A volunteer staffed central wrap area stocked with bubble wrap, packing paper, tape, and bags will be provided for customer convenience. Artists do not need to provide customer packing materials.

Amenities

Booth sitters for breaks, water, artists' breakfast reception Saturday morning, free parking, free admission, volunteer assistance for unloading, volunteer staffed central wrap station, art racks and hooks or table provided.

Artist Awards/Reception

A breakfast reception for **artists only** will take place on Saturday, July 23 from 10:00am-11:00am. The breakfast is sponsored by Whole Foods Market. Prizes of \$150 for Best of Show, \$100 for 1st place, \$75 for 2nd place, \$50 for 3rd place, and two honorable mentions at \$25 each will be awarded.

Eligibility

Visual artists in all mediums including, but not limited to acrylic, oil, watercolor, photography, metal, sculpture, ceramics, jewelry, and glass are eligible.

Application Process

- Artists may apply by:

- Mail in application below. Applications that are submitted by mail should include a disc with images or the images can be emailed to hmarx@ci.tualatin.or.us with subject line: "ArtSplash Application-Artist last name"
- Submit **up to 4 digital images** that best depict your current work. Images must be in .jpeg format. Images do not have to be of work planned for this show.
- Artists may enter in multiple categories by submitting a separate entry for each category.
- Up to two artists may collaborate on a single category and enter using one entry form. Both artist names are required on the application.
- A non-refundable application fee of \$35 must be paid by application deadline. The fee may be paid by credit card by following the link on the confirmation email or by check mailed to address below. The application fee must be received by May 3, 2016 at 5:00pm.
- The jurors are interested in how you make your work. Please give a short description of the medium and technique used.

Jury Process

Applications will be reviewed by a jury comprised of selected individuals from varied backgrounds who embrace the philosophy and goals of ArtSplash.

Rules of Participation

ArtSplash expects artists to comply with the following rules. ArtSplash reserves the right to remove any artist from present or future ArtSplash shows for non-compliance with these rules.

- All work displayed must be original, handcrafted work that is similar in style, quality, and process to the work submitted to the jury
- Artist may show artwork only in categories in which they were accepted.
- Artists may not share their booth with another artist unless he/she has collaborated with the accepted artist. Both artist names must be included on the application. Collaborating artists may submit one application and pay for one booth.
- Artists must be present in their booth during show hours. They must keep their booth intact during the entire show. Volunteers are available to relieve you during the show.
