A. CALL TO ORDER

Committee chair, Buck Braden, called the meeting to order at 6:32pm.

B. APPROVAL OF MINUTES

Minutes of November 18, 2019 were approved on consensus by a motion from Kathleen Silloway and second by Brett Hamilton. Minutes of December 10, 2019 were approved on consensus by a motion from Brett Hamilton and second from Mason Hall. Minutes of January 21, were approved on consensus with a header correction. Motion to approve was made by Kathleen Silloway and seconded by Mason Hall.

D. NEW BUSINESS

1. Tualatin Moving Forward Sidewalk Art

Staff, Julie Ludemann, updated the committee on the submission process, which is currently open and available on the City's website. It is hoped that there will be submissions for review at the March/April TAAC meetings.

2. Donation

Artist Jan Rothermel has offered to donate her painting "Marking Time" to the City. The committee voted to accept the donation on a motion from Kathleen Silloway, which was

seconded by Mason Hall. Staff will contact the artist for delivery of the piece and incorporation into the Visual Chronicle.

3. 2020 Meeting Schedule

Julie Ludemann, staff, presented the 2020 TAAC meeting schedule for review.

4. Committee Chair voting

Current Committee Chair, Buck Braden, was nominated to continue in this position for 2020 by Brett Hamilton and Mason Hall. Brett Hamilton nominated Janet Steiger-Carr as Vice-Chair. Mason Hall moved to accept the nominated candidates, Kathleen Silloway seconded the motion. The motion passed on consensus. The TAAC chair for 2020 is Buck Braden, and the Vice-Chair is Janet Steiger-Carr.

5. Viva Tualatin

Julie Ludemann, staff, announced that Viva Tualatin will be held in Tualatin Community Park on July 25, 2020. The committee discussed ways they could be involved in the event. Ideas included hosting a TAAC booth to educate the public on the arts in Tualatin, display selections from the Visual Chronicle, sales of postcards with images from the City's collection, and a public survey on art. Also discussed was incorporating actors portraying famous artists, or locally significant historical figures involved in the arts. Janet Steiger-Carr and Mason Hall volunteered to research options for this.

E. OLD BUSINESS

1. Storm Drain Art

Staff, Julie Ludemann, met with a representative from Tualatin Riverkeepers to discuss an additional storm drain mural to be installed in Spring 2020. Tualatin Riverkeepers will reach out to the artist, Emily Wymps, who was selected by the committee to install the second mural in the City.

2. Intersection Art

Staff, Julie Ludemann, met with representatives from the City's streets, engineering, and community engagement teams to discuss future street art concepts. The turnaround at the Tualatin Commons (SW Nyberg St.) was determined to be a satisfactory location for the installation. Installation of the art will not occur until the splash pad construction project is complete, with a proposed date in Summer 2021.

3. Utility Box Wraps

Staff, Julie Ludemann, announced that the traffic control box on the corner of SW Martinazzi and SW Boones Ferry, adjacent to the Tualatin Library, has been selected as an appropriate location for the first utility box wrap installation. The committee voted to accept the Jan Rothermel painting currently in the City's collection for installation on the traffic box.

4. Veterans Memorial

Staff, Ross Hoover, updated the committee on the Veterans Memorial project. TAAC member Brett Hamilton updated the committee on the most recent stakeholder meeting and encouraged members to attend the February 20 public meeting and take the survey online.

Tualatin Moving Forward Art Contest

Calling all artists who live, work, learn, or play in Tualatin!

As part of the Tualatin Moving Forward transportation bond program, we are enhancing neighborhood safety and access to schools by installing new sidewalks throughout the city. At many of these installations, we will stamp community-created art on the wet concrete, leaving a lasting impression for all to enjoy. The Tualatin Arts Committee will select a range of drawings from volunteer artists of all ages. The Tualatin Library's Makerspace team will turn these drawings into stamps that we will use to print on freshly poured concrete!

Artwork Submission Instructions

All materials must be submitted by June 1st, 2020.

- Line drawings are the best kind of artwork for creating stamps. Minor adjustments may be necessary to convert the drawing into a stamp.
- The art should be approximately 8" x 10", so it can fit on the concrete stamp.
- Submissions may be on paper or high resolution digital files with a resolution of at least 600dpi. The file must be under 5MB.

You can submit your art in one of three ways:

Artist releases the City, its officers, employees, and agents from any and all liability for damage, loss, or misappropriation of the Art Entry during and subsequent to the Art Competition. Artist agrees to indemnify, hold harmless and defend the City, its officers, employees, and agents against any and all claims of any nature whatsoever, including, but not limited to, claims of copyright infringement, by any party whatsoever, arising out of or in any way related to the submission of the Art Entry in the Art Competition.
