A. APPROVAL OF MINUTES

Minutes of the October 17, 2023 meeting were approved on a motion from Jeannie Hart and second by Brett Hamilton.

B. COMMUNICATIONS

Council Liaison Councilor Bridget Brooks acknowledged the work that the Parks and Recreation Department does in October for the Pumpkin Regatta, and also expressed appreciation for the Veterans Breakfast. Julie Ludemann announced that Jessel Champoux, consultant from Shapiro-Didway, will assist with the next phase of the project by advising on logistical issues for the artist presentation process, as well as creating a scoring document, based on previous planning efforts and criteria. The committee provided input and questions on the process, including how the interview questions will be determined, possible schedule and any potential site visits, whether virtual or in-person. Presentations are tentatively scheduled for February 24 and 25. Julie Ludemann will continue to meet with the consulting team on
