

### 124th (Estimated Cost \$30 million)

- MSTIP 3C \$8 million
- \* MSTIP 3D \$12 million (124th)
- \* MSTIP 3D \$10 million (Basalt Creek Imp.)

### Basalt Creek Parkway Ext (Estimated Cost \$35 million)

- MSTIP 3D \$1 million (Basalt Creek Imp.)
- \* Regional Flex Funds \$2.2 million (Tonquin/Grahams Ferry)
- Further funding will be needed from Federal, MSTIP, TDT, Local SDC

# 124<sup>th</sup> Highlights


- Extension of 124<sup>th</sup> to Tonquin and a new Basalt Creek Parkway from Tonquin to Grahams Ferry.
- Interim 2-3 lane cross section, walls and bridges built to future 5 –lane cross section.
- \* Tonquin and Grahams Ferry improved to 3-lanes
- \* Tonquin/Grahams Ferry intersection rebuilt
- Improved Rail crossing on Tonquin and overcrossing of the Rail for Basalt Creek
- \* Realigned curves on Tonquin in front of TVF&R
- \* Improved sight distance on Tonquin and Grahams Ferry.
- \* 6-7 foot wide shoulders to accommodate bikes

### 124<sup>th</sup> Schedule

- \* Right-of-Way acquisition nearing completion.
- \* Bids were opened on 18 November 2015.
- \* The Board of County Commissioners approved the bid award to Kerr Contractors on 15 December 2015.
- \* Anticipated on site construction start April 2016
- \* Project Completion December 2018


### **Construction Schedule**

 The vicinity maps shows the primary focus of the first stage of construction, April 2016 – August 2017




### **Construction Schedule**

- SW 124th Avenue Extension and Basalt Creek Parkway will open to traffic.
   September 2017
- Construction will then commence on the Grahams Ferry Road and SW Tonquin Road intersection.
   September 2017 – December 2018.



## Basalt Creek Transportation Refinement Plan

- The Basalt Creek Transportation Refinement Plan was a joint effort involving five agencies and the public.
- The east-west alternative was selected by all five agencies and used to update the County's TSP



### Basalt Creek Parkway Ext.

- Part of the east-west alternative in the Basalt
  Creek Transportation Refinement Plan
- \* Will extend the newly built Basalt Creek Parkway from Grahams Ferry to Boones Ferry.
- \* Environmental work will begin in 2016
- \* Final Design work will start Oct 2017
- If additional funds are budgeted Construction could start in the summer of 2019 and be complete as soon as 2022.
