EXECUTIVE SUMMARY:

BACKGROUND

The City of Tualatin and the Tualatin Development Commission have a long and successful history of fostering economic growth and community redevelopment. The City has used Tax Increment Financing (TIF) to fund critical public infrastructure projects that have paved the way for millions of dollars of private investment and have spurred continued job growth in the City through two urban renewal districts:

- Central Urban Renewal District (CURD)
- Leveton Tax Increment District (LTID)

These two districts were formed for very different purposes, and each was successful in its own way.

The Central District (CURD) was intended to alleviate blight in downtown Tualatin, providing a sense of place, and a more vibrant urban setting. Implementation of the Tualatin Commons is one of CURD's greatest accomplishments.

The Leveton District (LTID) was created to open up new lands for employment and industry, and over the last 26 years, it has accommodated over 35 new employers, bringing thoughts of jobs to the City of Tualatin.

While each district was formed for different purposes, they shared a common result – increased property value. The assessed value of the Central District increased by \$180 million between 1975 and 2010. Likewise, the assessed value of the Leveton District increased by \$255.5 million between 1985 and 2010. As a result, the close down of the urban renewal districts returned thousands of dollars of assessed value to other important services such as schools and fire.



CITIES WITH URBAN RENEWAL



WHAT IS BLIGHT?

- Blight is a precondition to any Urban Renewal Area
- Specific criteria defined by state statue, generally covers:
 - Underdevelopment or underutilization of property
 - Poor condition of buildings
 - Inadequacy of infrastructure including streets and utilities

HOW DOES AN URBAN RENEWAL AREA FUNCTION?

1. Income Source

Yearly property tax collections based on growth within Boundary (more detail on mechanism in later slide)

2. Expenses


Projects, programs, and administration

3. Spending Limit


- Capped by Maximum Indebtedness (MI):
 - The total amount of money that can be spent over the life of the district on projects, programs, and administration.

PROPERTY TAXES AND URBAN RENEWAL

- Urban Renewals Division of Taxes does not increase property taxes, it uses increases in property taxes that were already happening
- Urban Renewal is a line item on your property tax bill
- The Assessor must go through the following steps when distributing Urban Renewal Taxes:
 - 1. "Calculation" of TIF to be collected
 - 2. "Distribution" of TIF Citywide to property tax payers
 - 3. "Collection" of property tax revenues



- No new taxes due to the division of taxes from Urban Renewal
- Schools are indirectly impacted by urban renewal
- There will be a line item for Urban Renewal on your property tax bill if this Plan is adopted
- There are no bonds or local option levies impacted by the proposed urban renewal plan unless bonds issued prior to 2001

IMPACTS TO TAXING DISTRICTS

- Urban Renewal does not provide new money
 - Diverts funds that would go to other property tax districts
- Continue receiving taxes on frozen base
- Temporarily forego taxes on any growth in Urban Renewal area
- Growth may not have occurred but not for urban renewal




URBAN RENEWAL AND LOCAL SCHOOL DISTRICTS

URBAN RENEWAL IMPACT Regular Taxing District




URBAN RENEWAL IMPACT Local Schools



STATE LIMITATIONS ON URBAN RENEWAL

- Population under 50,000
 - 25% of Assessed Value of Property in City
 - 25% of Acreage of City
- Existing Plan limitations:
 - Can not be increased in size by more than 20% of original Plan acreage
 - Maximum Indebtedness (MI) can not increase by more than 20% of original MI, indexing
 - May increase MI above 20% as adjusted only with concurrence from 75% of other taxing districts

Basalt Creek Planning history

- 2004 Metro brings area into Urban Growth Boundary
- 2011 Metro, County, Tualatin, Wilsonville enter into IGA for planning
- 2013 Basalt Creek Refinement Plan acknowledged by partners, 124th and Basalt Creek Parkway added to Transportation System Plans (TSP)




Basalt Creek Planning history

- 2017 South County Industrial Study prioritizes major projects and identifies funding sources
- 2018 Tualatin and Wilsonville adopt
 Basalt Creek Concept Plan, confirm Basalt
 Creek Parkway as city boundary
- 2019 Tualatin, Wilsonville and County adopt Urban Planning Area Agreement



BUILD Grant

- Better Utilizing Investments to Leverage Development (BUILD) transportation grant
- \$32.4M project, \$23M unfunded
- Leverages \$100M of investment in vicinity



Basalt Creek Parkway scope

- Five-lane, limited-access arterial
- Bicycle and pedestrian facilities
- 600-foot bridge
- New, signalized intersection at Boones Ferry
- Right-of-way needs to be determined; one residence may be purchased

Basalt Creek Parkway Extension (Grahams Ferry to Boones Ferry)

- Today: Environmental work underway
- September: Anticipated Federal Highway Administration concurrence on Categorical Exclusion
- October: Final design work
- Summer 2021-2024: Construction (pending funding)

Basalt Creek Parkway environmental

- Wetland delineation submitted to Department of State Lands and Army Corp of Engineers
 - Joint permit application required to address jurisdictional waters. Includes Department of Environmental Quality certification.
- Water quality treatment required
- No known threatened/endangered species; field survey is underway to confirm




Basalt Creek Parkway environmental Archaeological investigation:

- 49 shovel probes; no significant resources identified
- Historical resources baseline conducted
- The Carlon School is recommended as a historical resource



Moms Demand Action for Gun Sense in America (www.momsdemandaction.org) is a grassroots, non-partisan movement of

Americans fighting for public safety measures that can protect people from gun violence and keep our families safe.

Moms Demand Action has a chapter in every state and, along with Mayors Against Illegal Guns, Students Demand Action and the Everytown Survivor Network, it is part of the nation's largest gun violence prevention organization, Everytown for Gun Safety, with more than 5 million supporters.

Moms Demand Action works with survivors, mayors, law enforcement officers, faith leaders, educators, gun owners, doctors and communities across the country who know there is more we can do to prevent gun violence. We do this work because every day 100 Americans die from gun violence and hundreds more are wounded. Gun violence is the second leading cause of death for American children and teens overall and the first leading cause of death for Black children and teens.

The daily toll of gun violence in America doesn't always make headlines, but this violence affects everyone, everywhere. It strikes big cities, small towns and rural communities.

We can support responsible gun ownership while doing much more to keep guns out of the wrong hands and create a culture of gun safety. That's why we advocate for the following, evidence-based policies to keep our families and communities safe:

- Keeping Guns Out of the Wrong Hands A Better Background Check System. Lawmakers need to close loopholes in the system, such as those that allow people to buy guns without a background check.
- Protecting Kids and Communities Supporting Red Flag Laws and Responsible Access to Firearms. To keep our families safe from mass shootings and reduce gun suicides, lawmakers must pursue policies like Red Flag laws, which allow family and law enforcement to intervene if someone poses a threat to themselves or others, before deadly tragedies involving firearms take place. Lawmakers must also limit easy access to firearms and accessories capable of inflicting mass casualties and encourage safe and responsible storage of all guns.
- Addressing America's Uniquely Lethal Domestic Abuse Problem Disarming Domestic **Abusers.** More than half of women murdered with guns in America are killed by an intimate partner or family member, and women are five times more likely to be killed in a domestic confrontation when a gun is present. Lawmakers must strengthen laws that help keep guns out of the hands of domestic abusers.
- Combating Daily Gun Violence Supporting Research, Law Enforcement and Local **Solutions.** The government needs to support law enforcement, researchers and local communities in their efforts to combat daily gun violence by funding new research into gun violence; community-driven, evidence-based interventions to curb city gun violence; and new tools to help law enforcement collect evidence, trace all crime guns, reduce trafficking and solve gun crimes.

It's time for our government to enact common-sense gun laws supported by the overwhelming majority of Americans. And if our elected officials choose not to act, we will mobilize voters to replace them with leaders who will

PROCLAMATION DECLARING THE FIRST FRIDAY IN JUNE TO BE NATIONAL GUN VIOLENCE AWARENESS DAY

DRAFT

This proclamation declares the first Friday in June to be National Gun Violence Awareness Day in the City of TUALATIN to honor and remember all victims and survivors of gun violence and to declare that we as a country must do more to reduce gun violence.

WHEREAS, every day, 100 Americans are killed by gun violence and on average there are nearly 13,000 gun homicides every year; and

WHEREAS, Americans are 25 times more likely to be killed with guns than people in other high-income countries; and

WHEREAS, protecting public safety in the communities they serve is mayors' highest responsibility; and

WHEREAS, support for the Second Amendment rights of law-abiding citizens goes hand-in-hand with keeping guns away from people with dangerous histories; and

WHEREAS, mayors and law enforcement officers know their communities best, are the most familiar with local criminal activity and how to address it, and are best positioned to understand how to keep their citizens safe; and

WHEREAS, in January 2013, Hadiya Pendleton, a teenager who marched in President Obama's second inaugural parade and was tragically shot and killed just weeks later, should be now celebrating her 22nd birthday; and

WHEREAS, to help honor Hadiya – and the 100 Americans whose lives are cut short and the countless survivors who are injured by shootings every day – a national coalition of organizations has designated June 7, 2019, the first Friday in June, as the 5th National Gun Violence Awareness Day; and

WHEREAS, the idea was inspired by a group of Hadiya's friends, who asked their classmates to commemorate her life by wearing orange; they chose this color because hunters wear orange to announce themselves to other hunters when out in the woods and orange is a color that symbolizes the value of human life; and

WHEREAS, anyone can join this campaign by pledging to Wear Orange on June 7th, the first Friday in June in 2019, to help raise awareness about gun violence; and

WHEREAS, by wearing orange on June 7, 2019 Americans will raise awareness about gun violence and honor the lives of gun violence victims and survivors; and

WHEREAS, we renew our commitment to reduce gun violence and pledge to do all we can to keep firearms out of the wrong hands, and encourage responsible gun ownership to help keep our children safe.

NOW, THEREFORE BE IT RESOLVED, that Mayor Frank Bubenik of the city of TUALATIN declares the first Friday in June, June 7, 2019, to be National Gun Violence Awareness Day. I encourage all citizens to support their local communities' efforts to prevent the tragic effects of gun violence and to honor and value human lives.
