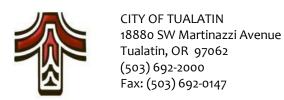

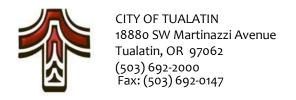

2. Applicant agrees as follows:

A.	To all the recitals and provisions of this contract and to comply with the requirements of Construction Permit			
	Number			
В.	To install and complete all improvements to existing public facilities required by Construction Permit Number			
Σ.	in accordance with the City standards and specifications and repair all existing and constructe			
	facilities, within and outside the development, which are damaged as a result of the development. All construction a			
	repair work is to be done in a good and workmanlike manner in accordance with applicable City standards and shown			
	more particularly on the construction plans for the development which have been presented to the City for acceptance			
C.	To complete all the public improvements necessary to comply with the requirements of Construction Permit Number			
	on or before the day of 20			
D.	That if work on the improvements specified in the contract are abandoned, incomplete, or deficient in any degree			
	after 20 City may pursue remedy under 1.C. above. The applicant and			
	its principals shall be jointly and severally liable to the City for any and all loss and damage from such abandonment of			
	failure, either from the greater expense of so completing or repairing faulty or damaged work, or from any other related			
	cause. Applicant further agrees that if any suit or action is pursued by City to enforce this contract or Construction			
	Permit Number the prevailing party shall be entitled reasonable attorney fees at trial and			
	on appeal. Venue for any such action shall be the Washington County District or Circuit Court. This agreement is in			
	addition to, and not in lieu of, any other enforcement action available to City including permit revocation and citation.			
E.	That this contract shall be binding on the Applicant and the Applicant's successors in interest and assigns and is			
	entered into in order to comply with the PWCC and Construction Permit Number
