A. CALL TO ORDER

Chris Paul called the meeting to order at 6:10 PM.

B. APPROVAL OF MINUTES

Chris Paul called for any corrections to the June minutes. Cosi Slider moved to accept the June 2025 meeting minutes; Erinn Stimson seconded. The motion passed unanimously.

1. Summer Outreach: Betsy Rodriguez Ruef led committee members in discussion about Viva Tualatin, which had reduced attendance this year from immigrant community members. Members who attended said they had good conversations with attendees. Chris Paul then reviewed plans for outreach at the Summer Concert Celebrating Pride on August 8. Committee members expressed interest in having a way to receive feedback from community members.

2. Workplan Adoption: Jerianne Thompson reviewed the final revisions to the committee's proposed workplan. Chris Paul called for a motion to adopt the workplan. Erinn Stimson so moved, with Cosi Slider seconding. With no further discussion, the motion passed unanimously. Committee members discussed topics to prioritize for first action, with consensus on starting with Acknowledgement of Native Land and People and with Public Safety and Community Groups identified as additional priorities alongside topics that will come before the committee this fall.
