




CENSORSHIP TRENDS

The majority of library censorship can be tied to organized campaigns. Pressure groups and the administrators, board members, and elected officials they influenced targeted 4,190 total titles in 2024. From 2001–2020, this constituency attempted to remove an average of 46 titles per year.







Library Funding & Governance - Risks

- Financial concerns from Washington County
 - Impact of federal funding cuts and tax cuts will impact state & county revenues
 - Uncertain environment for county regarding funding for mandated services
 - County cannot provide specific commitments regarding General Fund allocations
- Resource pressures at some local agencies
- Uncertainties about collection centralization costs; potential for reduced services to libraries
 - WCCLS may need to cut services to member libraries to take on collection centralization work

Library Local Option Levy

MEASURE 34-345 PROPOSED LOCAL OPTION LEVY

If passed, Measure 34-345 would fund:

- · Reading and learning support for kids & teens
- · Central services that efficiently link libraries together
- Open hours and access to books & materials
- · Reading events for children

If passed, how much would Measure 34-345 cost taxpayers?

- If passed, the proposed measure would authorize an increase in property taxes.
- The proposed measure would cost property owners \$0.37 per \$1,000 of assessed property value. The owner of a home assessed at \$348,600 would pay approximately \$129 per year, or \$10.75 per month.
- The measure would raise \$188,915,688 between July 2026 and June 2031.

What would happen if Measure 34-345 does not pass?

If the proposed measure does not pass, library services would not be provided as proposed and property taxes would not be increased.

Library Local Option Levy



Tualatin Public Library is a member of Washington County Cooperative Library Services (WCCLS). About 30% of Tualatin Library's funding currently comes from a local option levy that will expire in June 2026. This measure would replace the current levy funding and runs through 2031. If passed, the Measure would cost property owners \$0.37 per \$1000 of assessed property value each year of the 5 year period.



Which Tualatin Library services did you use during the past year?





Which Tualatin Library services did you use: 2025 vs 2024

















How would you rate the collection areas you most frequently use?




What makes Tualatin Library's collection different from other libraries you visit?








Library Visits – by month
