1. Tualatin Together Presentation on Smoke and Tobacco Free Parks and City Property Paul Hennon introduced Cyndy Hillier who provided an overview of the role of Tualatin Together and their current smoke and tobacco free initiative that would include Tualatin's municipally owned and maintained properties, including parks and the library. Carla Bennett provided additional information about tobacco prevention issues. The presentation of this information was followed by discussion. There was a motion by Bruce Andrus-Hughes, seconded by Connie Ledbetter, that TPARK support Tualatin Together's smoke and tobacco free initiative to prohibit smoking and use of tobacco products, including e-cigarettes, in Tualatin's park properties. The motion passed 6-0-0.
