6. Project Prioritization Discussion

Ross Hoover reviewed the prioritization ratings for projects. The committee discussed the ranking order and indicated their consensus for the project prioritization.

Ross Hoover provided an overview of the Parks & Recreation Master Plan (Chapter 6 Implementation) funding sources for capital projects. These funding opportunities include property taxes, charges for services, parks system development charges, transient lodging tax, general obligation bond, operating levy, park utility fee, public agency grants, philanthropic grants, and donations. Committee members discussed the funding methods and how the master plan moves toward implementation.

Ross Hoover proved an update on maintenance activities, projects and staffing.




