# **REQUIRED SUBMITTAL ELEMENTS**

Please submit all materials electronically through the following link:

Completed and signed application form
Property owner authorization via signed application form or letter of authorization
Elevations drawn to scale with sign, wall, and building dimensions
Site plan drawn to scale with north arrow and sign location (for freestanding signs, include dimensions from property line along public rights-of-way)
Identify any existing signs on the subject property and include their dimensions and square footage
Application fees

- o Please refer to Chapter 38 of the Tualatin Development Code (TDC) for information regarding sign standards.
