Failure to: (1) Raise an issue in the hearing in person or by letter to the address above, or (2) Provide sufficient detail and clarity to enable a decision-maker to respond to the issue, precludes appeal to the Oregon Land Use Board of Appeals (LUBA) on that issue.</li> </ul>
HERE IS WHAT THIS MEANS: The Tualatin City Council is proposing to amend Chapters 1 and 2 and 31-80 of the Tualatin Development Code (TDC). The purpose of these amendments is to make the code easier to use, read and understand. The proposed changes improve the organization of the code, fix inconsistencies and conflicts, streamline and clarify pro- cesses, update outdated language, introduce tables to improve visual clarity, and address State law requirements.
