This is an addition that will expand the use of the current emergency vet clinic (EVCOT) and vet diagnostic imaging clinic (VDIC) located at 8250 SW Tonka Street. This addition consists of several small additions on the north, south and west side to the existing building and a large addition to the east. Total additional square footage to the building is approximately 3,600 sf. The expansion includes two new exam rooms, a staff break room, a new laundry room, more dog and cat cages, and a large separate area for VDIC's imaging clinic.

The current number of trips to the site is 50 for EVCOT in a 24-hour period, and 21 for VDIC in the standard 8-5. They do not expect an increase with the expansion.

The traffic flow and circulation will not change with this addition, and the sight distance at the sites access points are not changing.

Below is a statement from the owner regarding the traffic on this site:

EVCOT's parking usage varies from day-to-day and varies hour-by-hour considerably. The general usage of the hospital is as follows:


Staff usage:

- EVCOT Staff varies between 6 to 15 people on site at any time based on the time of day. There are large times of day where we may not have any clients physically present at the building due to staffing and wait times.
- VDIC Staffing is typically 5-8 staff members at a time on site during daytime hours (8am -5 pm)

Client Usage

- EVCOT clients average ~3 to 3.5 clients per hour during out busiest days (typically holidays and weekends). At most we have 8-10 clients at the building at any given time. Those clients may be present for 1-2 hours depending on what is happening in the hospital.
- VDIC clients average 2-3 clients per hour during daytime hours.




