Project Location:

- Existing Wireless Facility located at 8930 SW Norwood Road (Water Tank site)

Proposal: Install an AT&T Wireless Facility that includes extending the existing 110-foot monopole 14 feet (124' total height), antennas, radios, and other ancillary aerial equipment. There will be a backup generator for emergency use only. The ground equipment will be contained within a 10'x15' secured area within the existing wireless compound.

Purpose: The facility will improve wireless coverage and capacity for AT&T customers within the area, along with public safety agencies/first responders, as part of the Nationwide Public Safety Broadband Network ("FirstNet").

At the meeting, we will provide an overview of the proposal, respond to questions, and record comments. Sign in sheets, meeting notes, and comments received will be transmitted to those in attendance and the City of Cornelius Community Development Department as part of their review of this proposal.

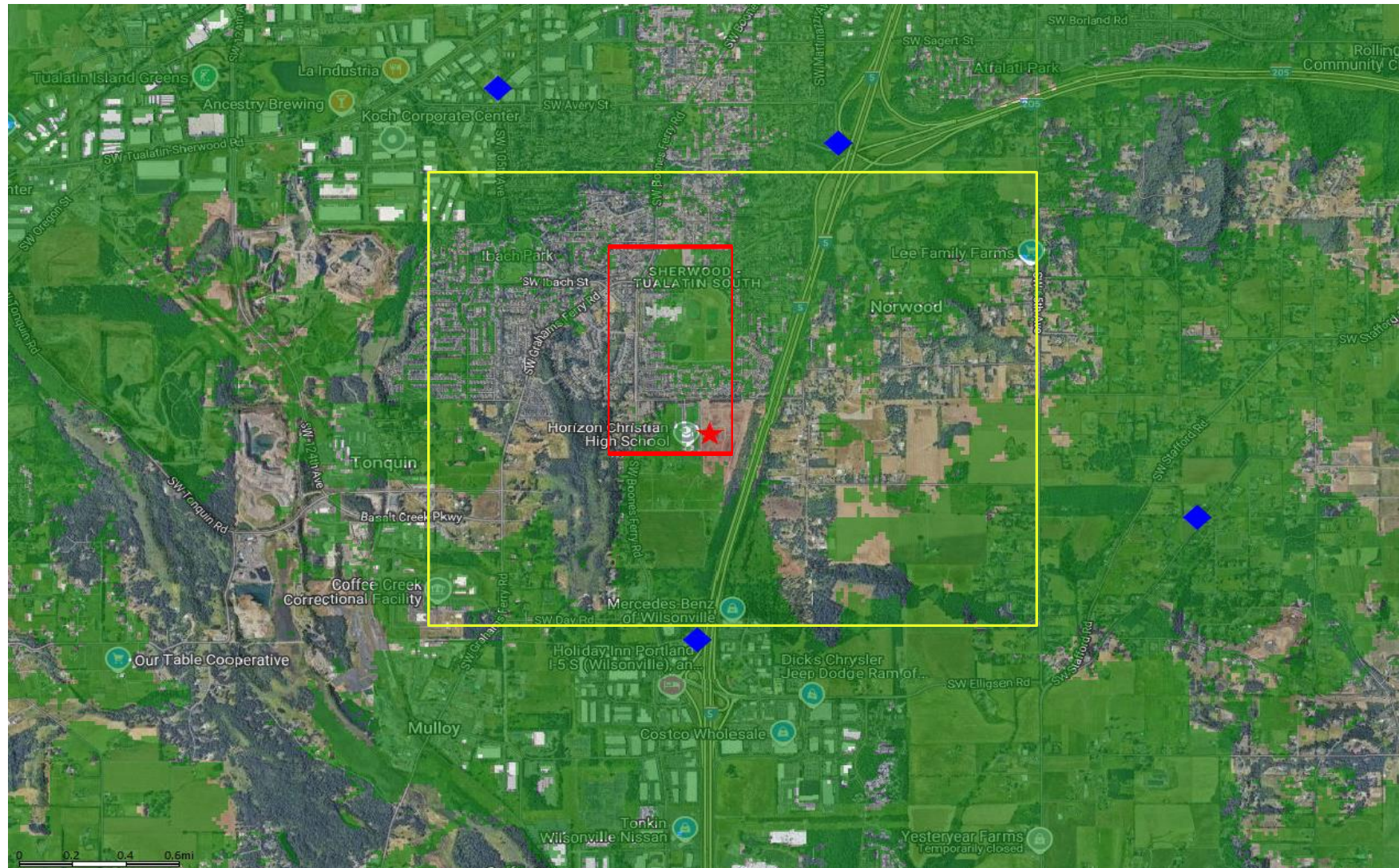

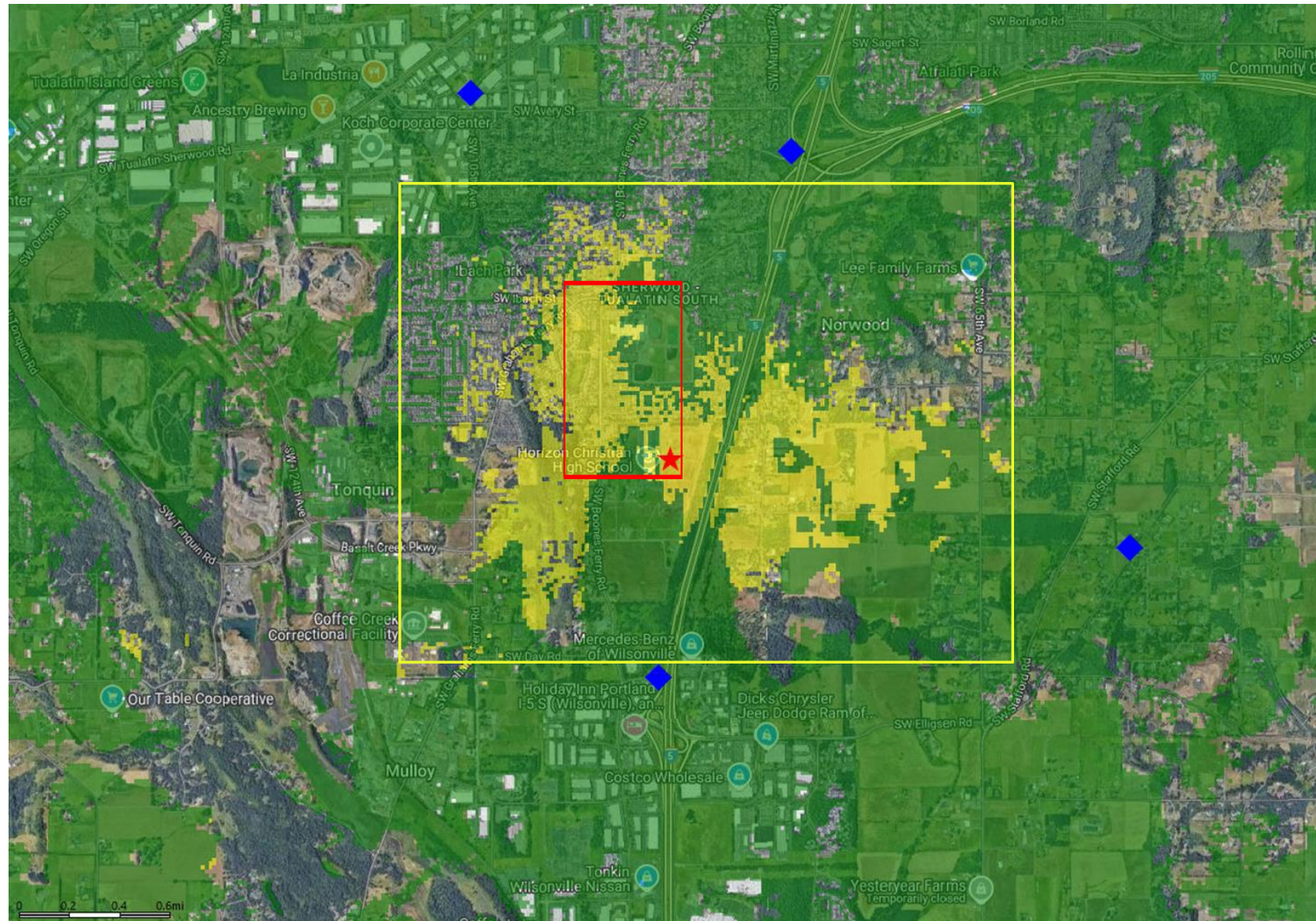

Proposal:

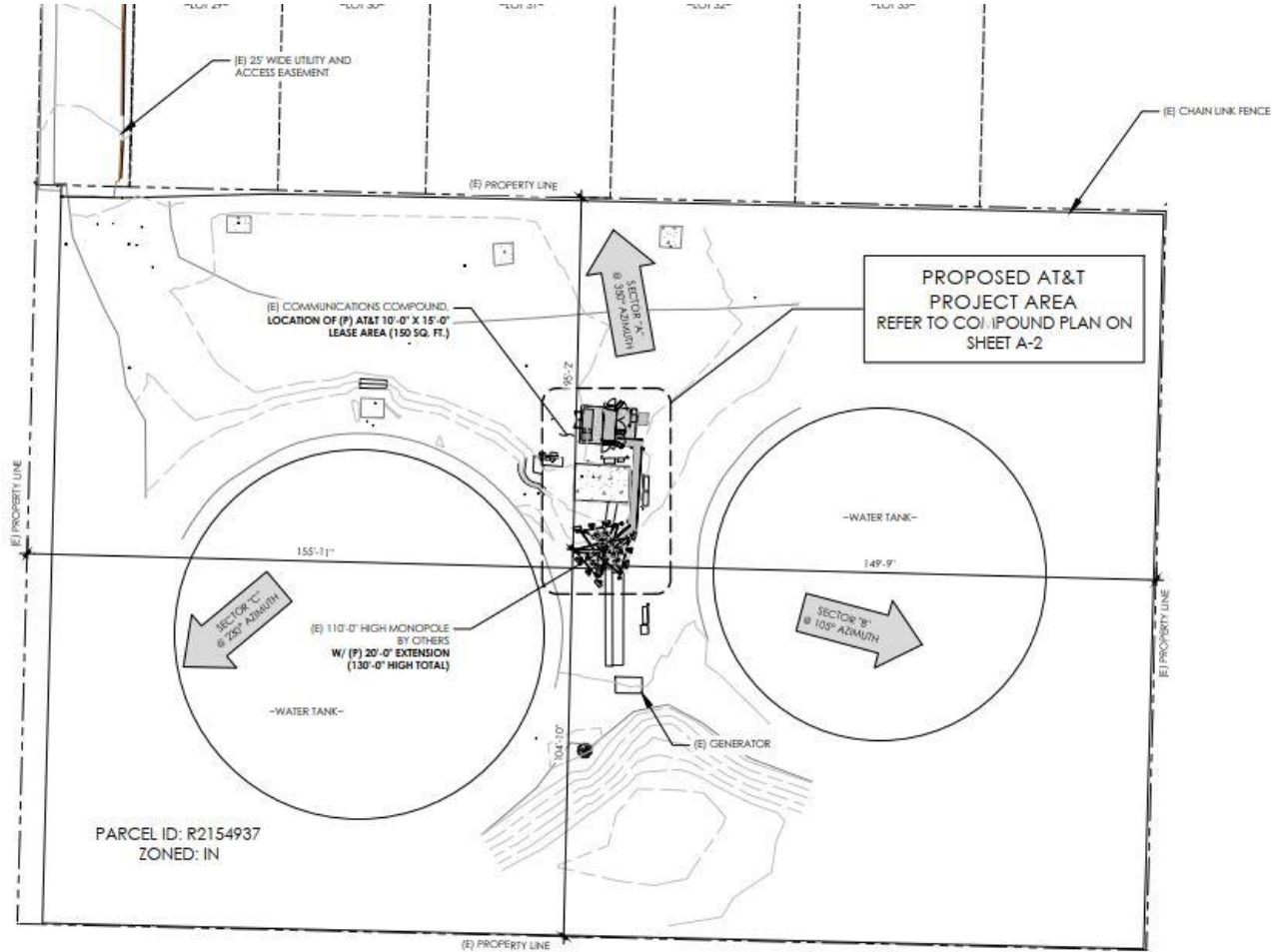
- AT&T proposes to collocate onto an existing 110-foot tall monopole (extension of 18') with antennas, radios, GPS and other ancillary operating equipment.
- The pole is designed to allow for other carriers (lower) – collocation.
- The ground lease is 10'x 15' (150 SF) inside the existing compound and there will be a backup generator to be operated for emergency use only.
- The location for the project is on the existing monopole between the two water tanks (city-owned property).
- Access will be from SW Norwood Road– existing driveway.
- Project is compliant with rules and regulations.



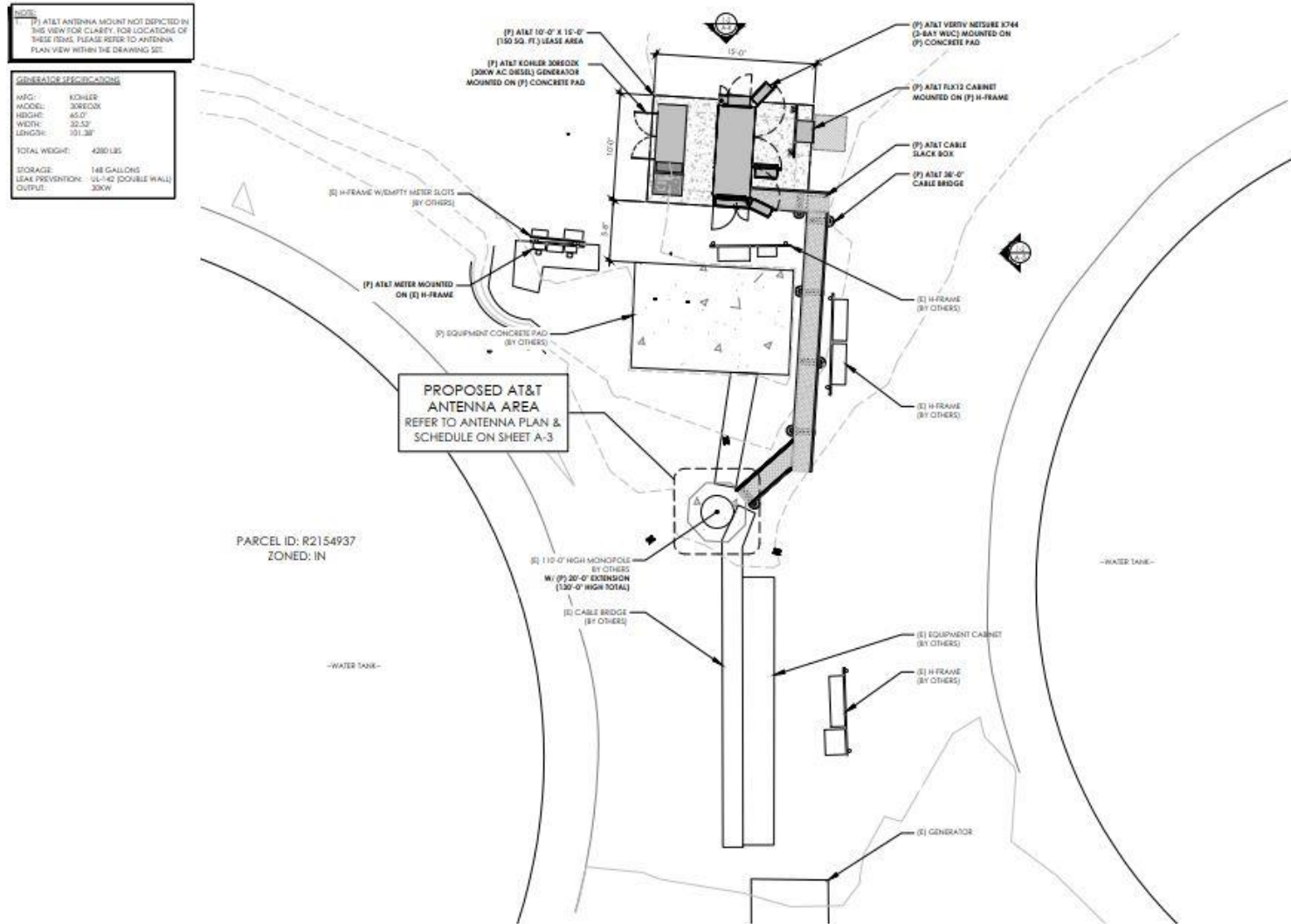

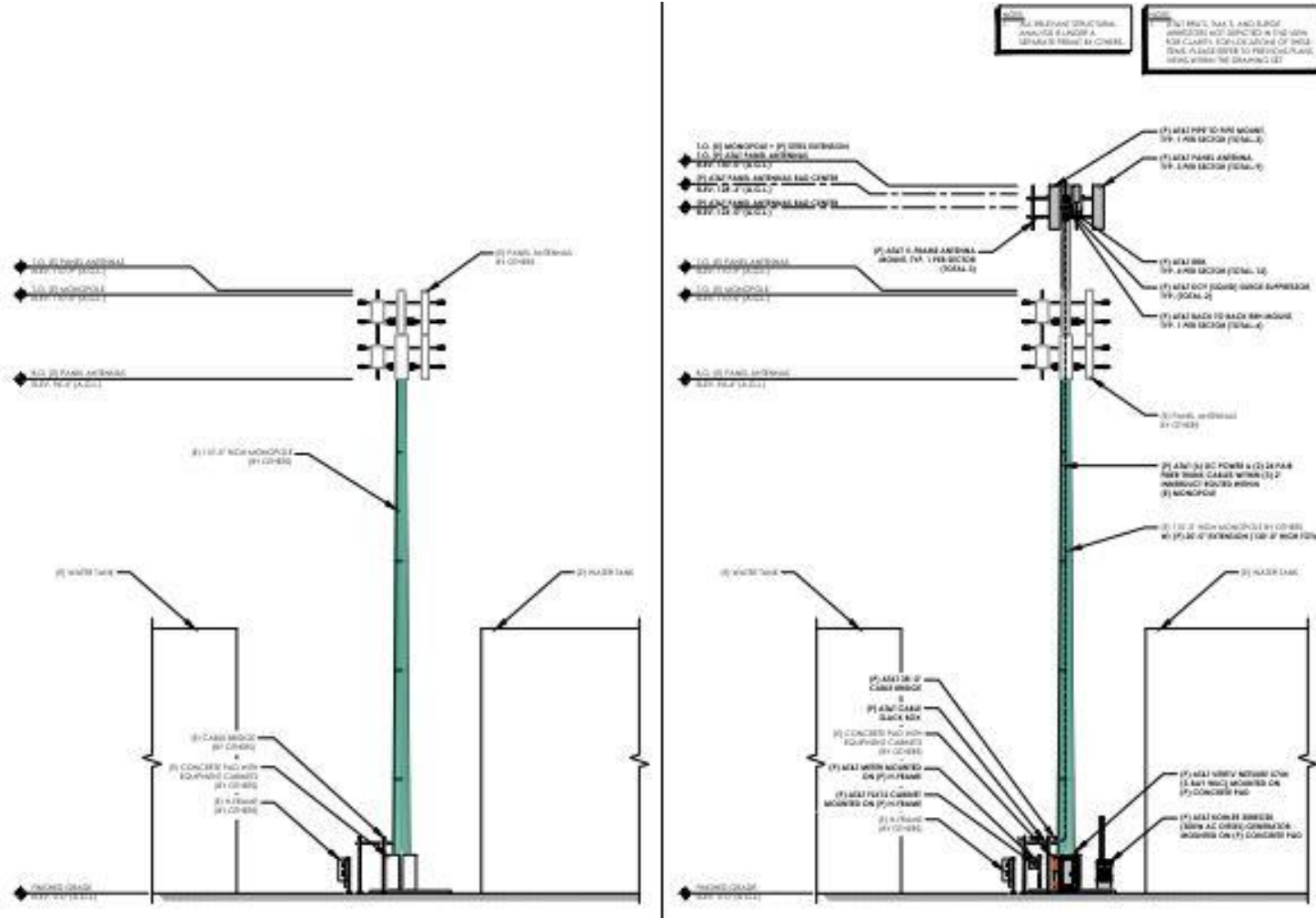
Project Site Plan:

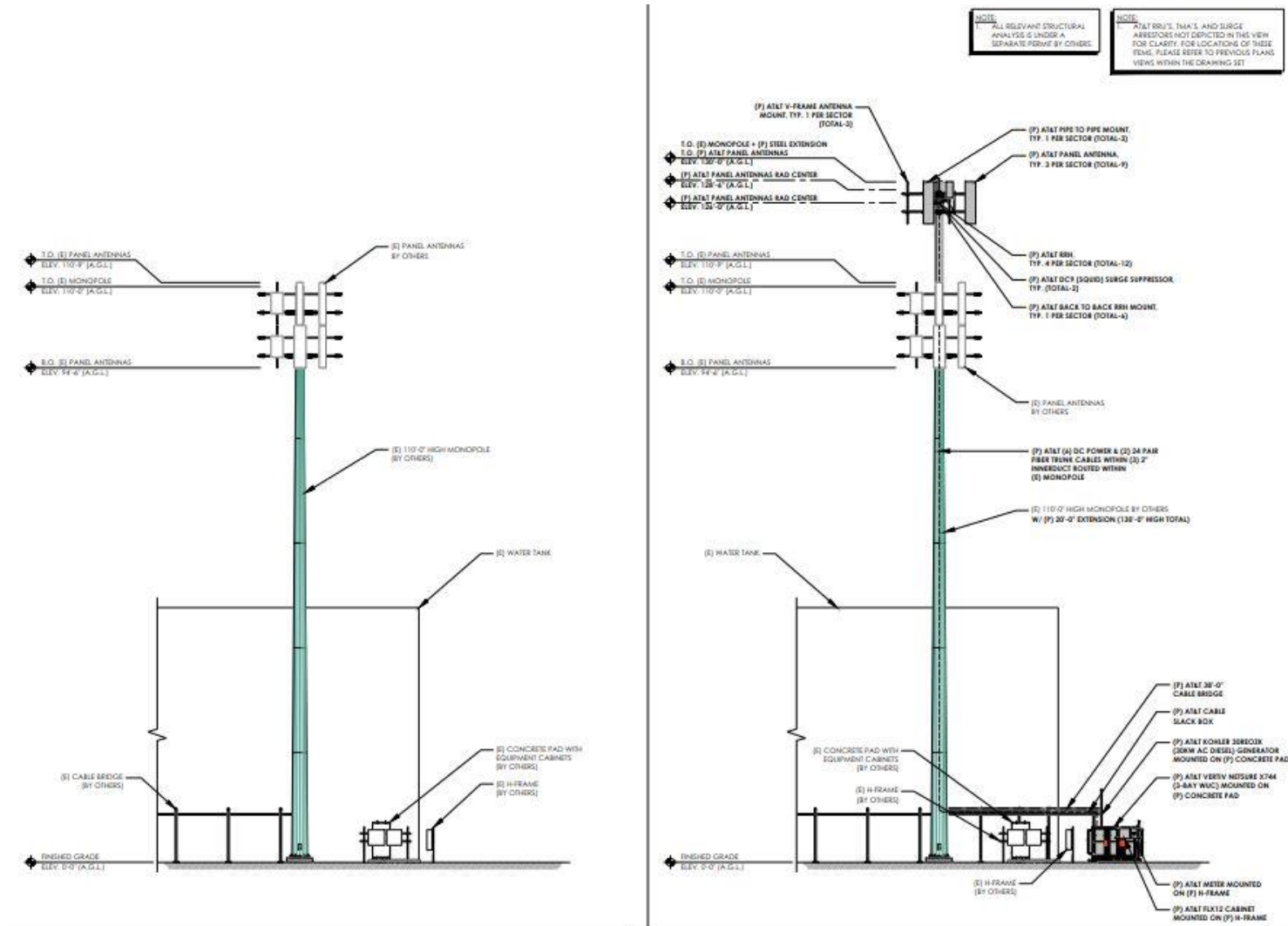

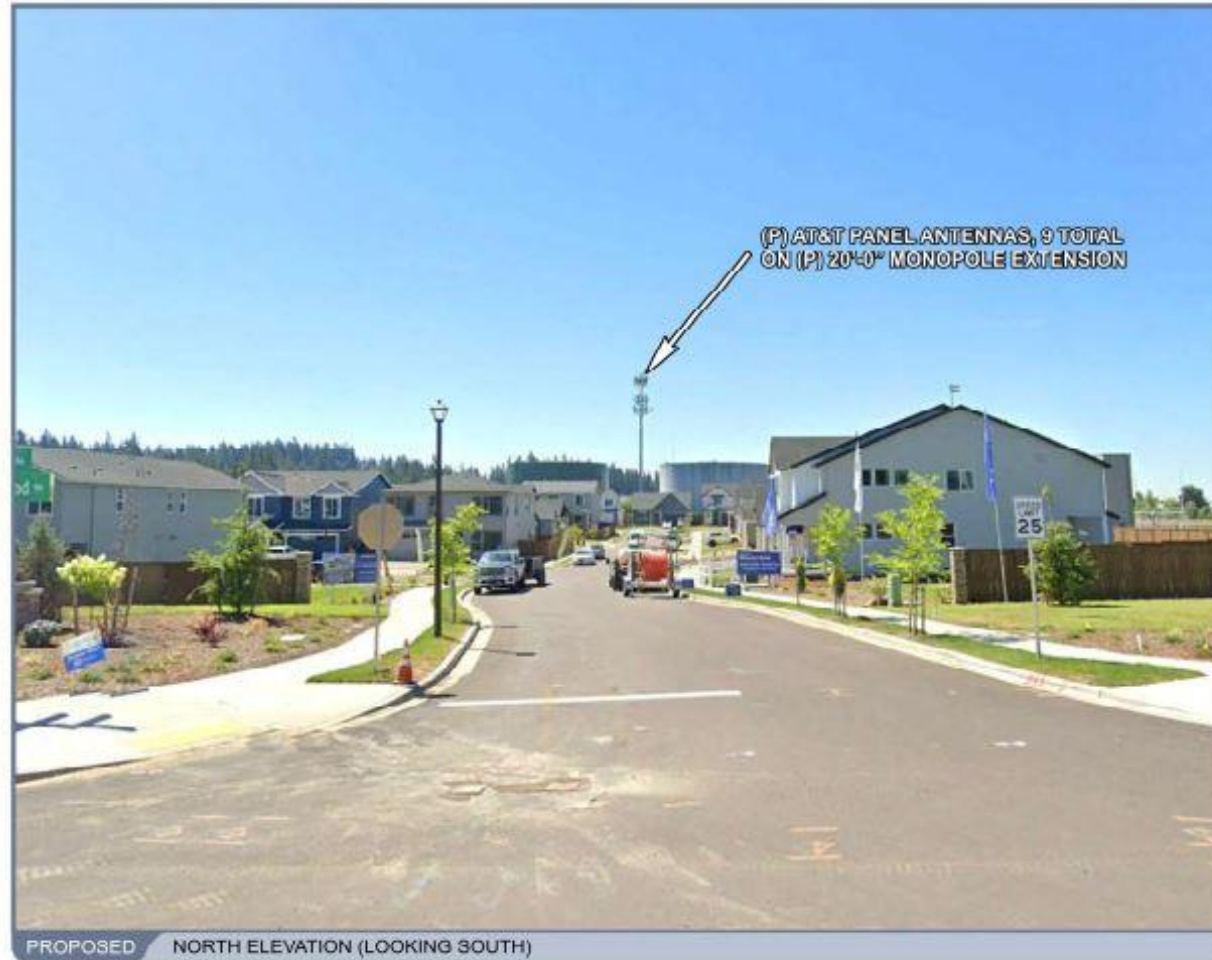

Radio Frequency (“RF”) Safety:

The FCC's mandatory RF exposure limits were developed based on information from health and safety experts including, but not limited to, the U.S. Environmental Protection Agency (EPA), the Food and Drug Administration (FDA), the National Institute for Occupational Safety and Health (NIOSH), the Occupational Safety and Health Administration (OSHA), the National Council on Radiation Protection and Measurements (NCRPM), the American National Standards Institute (ANSI), and the Institute of Electrical and Electronics Engineers, Inc. (IEEE).

NEIGHBORHOOD MEETING – FOLLOW-UP NOTES
CITY OF TUALATIN
AT&T PD33 BOONES & IBACH WIRELESS FACILITY

FEBRUARY 27, 2025

Greetings:

Thank you again for attending the informational neighborhood meeting on Saturday, February 22nd to discuss AT&T's proposed service improvements. We appreciate the questions and comments we received. The purpose of this letter is to provide responses to the questions that were posed by residents. In this instance, there were two questions:

1. What is the timeline for permitting?

***Response:** Again, the project requires architectural review (Type II) and is decided upon by staff. There are a few set timelines involved, including: determination of a complete application (30 days), Notice of Application with a 14-day comment period, staff decision (60 days), appeal 14 days. This, in total, is about 4 months. If the application, is submitted in March, a final decision would be in July. There is a building permit process which will take about 2-3 months. Thus, the projected construction could begin sometime in October (as we stated).*

2. Will the planned facility generate any noise?

***Response:** No substantial amount of noise will be generated from AT&T's equipment to adjoining properties. A noise study has been prepared which was given out at the meeting. In general, noise is limited to 70 dBA during daytime hours (7A to 10P). During nighttime (10P to 7A) the permissible sound level is decreased by 20 dBA, or 50 dBA.*

As it applies to this project, the operating equipment will generate approximately 71 dBA at the point of operation. The actual noise heard dissipates further away by about 22 dBA 60 feet away (the closest residential property). Therefore, the actual noise generated to the property line is 49 dBA, which meets the city requirement day or night.

The backup generator (emergency use only) will generate about 65 dBA 23 feet away from the equipment. Again, noise will dissipate further away; thus, the predicted noise level is 57 dBA which meets the daylight noise requirement. Again, this is for emergency use only.



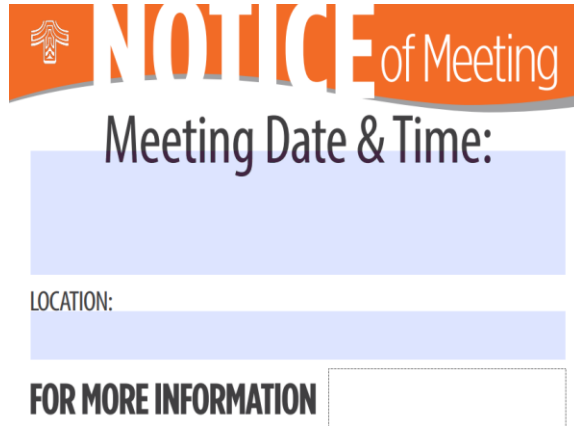
